MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is executed at Guwahati on the 30th day of September' 2013

BETWEEN

The Authority of Gauhati University on behalf of which the Registrar, GU is the one part which is solely considered as the 1st party in one side

AND

The Public Health Engineering Department on behalf of which the Executive Engineer, Guwahati Division No.-II, Bamunimaidam, Guwahati-21 is the other part which is solely considered as 2nd party in the other side.

As of now, both 1st and 2nd parties are collectively referred to here as PARTIES.

Now the both parties come into an Agreement as per the Minutes dated 3/6/2013 for release of a ^{advance} Grant-in-Aid of Rs. 25,00,000.00 (Rupees twenty five lakh only) for upgradation of water supply scheme of Gauhati University . Also as per minutes the monthly rent be enhanced upto Rs. 2,00,000.00 (Rupees two lakh only) from Rs. 1,50,000.00 (Rupees one lakh fifty thousand only)

Now, therefore both the parties witnesseth as under :-

- 1) That the Gauhati University decided to recommend a sum of Rs. 25,00,000.00 (Rupees twenty five lakh) as an advance to the Public Health Engineering Department.
- 2) That the advance amount be released to the Executive Engineer (PHE), Guwahati Division No.-II on behalf of PHED.
- 3) That this advance amount be adjusted against monthly charges at the rate of Rs. 75,000.00 (Rupees seventy five thousand only) per month.
- 4) That the existing monthly rent of Rs.1.5 lakh be enhanced to Rs. 2.0 lakh with the effect from the 1st of July' 2013 against proposal for enhancement of water charges.
- 5) Further, it is to be stated that no further enhancement will be made for next 5 (five) years from the effect date of enhancement of Rs. 2.0 lakh i.e, 1st of July'2013.

This Agreement i.e, Memorandum of Understanding is signed mutually by the deponent of each 1st party and 2nd party on this day of 30th September' 2013 at Guwahati.
